Australian Parts Manufacturer Approval (APMA) No: CASA.APMA.0013

In accordance with regulation 21.303 of the *Civil Aviation Safety Regulations 1998 (CASR)*, CASA has found that the design data, as submitted by Aerotest Pty Ltd ('the Manufacturer') meets the airworthiness requirements of the CASR applicable to the products on which the parts are to be installed.

Additionally, CASA has determined that the Manufacturer has established the Fabrication Inspection System (FIS) required by subregulation 21.303 (11) of CASR, and accordingly, approval is hereby granted to the Manufacturer to produce the parts listed in the enclosed Supplement in conformity with the approved design data.

Manufacture in accordance with the established fabrication inspection system is approved at the locations given in the supplement enclosed in this letter.

This approval is issued subject to the Manufacturer complying with the requirements of Subpart 21.K of CASR.

Approval Conditions

This approval is issued subject to the following conditions:

- 1. The Manufacturer must permit CASA to inspect upon request its manufacturing facilities, FIS, methods and procedures provided in Aerotest Pty Ltd, Quality Manual Revision 3, dated 04 January 2021 (or later approved revision).
- 2. Parts produced under the terms of this approval must be permanently marked with identification information in accordance with regulation 21.865 of CASR, except for the provision of paragraph 21.865 (4) (e) of CASR.
- 3. The Manufacturer must perform a full First Article Inspection (FAI), or a partial FAI for the affected characteristics, when there is a lapse in production of two years for any item listed in the APMA Supplement.
- 4. Parts, appliances or services furnished by any suppliers located in a foreign country may not be used in the production of any APMA product unless:
 - That part or service can and will be completely inspected for conformity at the authorised manufacturer's Australian facility; or
 - CASA has determined that the supplier's location places no undue burden upon CASA in administering the applicable airworthiness requirements; or

 The parts/services furnished by the foreign supplier are approved for import to Australia in accordance with regulation 21.502 of CASR.

The design data listed on the Supplement enclosed with this letter of approval is to be considered as approved data. This data is not to be altered by the Manufacturer unless permitted or approved by CASA.

Note: Please be advised that CASA has implemented a change to the APMA numbering convention. The APMA issued to Aerotest Pty Ltd will now be issued as CASA.APMA.0013. All CASA Form 001's issued from the date of issue of this authorisation should now have CASA.APMA.0013 entered in Block 13c (CASA Approval No).
