4. Parts, appliances or services furnished by any suppliers located in a foreign country may not be used in the production of any product unless:
 - a. That part or service can and will be completely inspected for conformity at the authorised manufacturer's Australian facility; or
 - b. CASA has determined that the supplier's location places no undue burden upon CASA in administering the applicable airworthiness requirements; or
 - c. The parts/services furnished by the foreign supplier are produced under the provisions of an Australian Bilateral Airworthiness Agreement or Bilateral Aviation Safety Agreement and approved for import to Australia in accordance with regulation 21.502 of CASR.
